Rules

1. You must be a member of the WAC to receive a grant.
2. Your application must be submitted prior to taking the training the grant is meant to cover.
3. The training you are seeking to take should not be duplicated by any course offered by the WAC.
4. The maximum award is currently targeted at around \$300 per person. Higher amounts can be awarded, however, if the training is of significant value to the WAC. Make your case!
5. The total amount of grant money available each fiscal year is set by the Board. When it is exhausted, no additional grants will be made unless the Board votes to allocate additional funds.
6. Depending on the amount of money being sought, you may be asked to perform some service to the WAC in exchange for the award.
7. The Board has final authority for reviewing and approving a grant.

Review Process

Your request for a grant will be reviewed during the next WAC Board meeting and voted upon at that time. You do not need to be present for the review. Board meetings are normally held on the first Thursday of each month, though some months may be skipped if there is no Club business to discuss.

Criteria Considered During Review

The principle criteria are the purpose of the grant money and your prior level of involvement in the WAC. Involvement in the WAC can be of many forms. Examples include but are not limited to having taught in one or more of the courses the WAC offers, having served on the Board, or helping to maintain Guye Cabin. Lastly, if multiple applications are competing for limited dollars, the Board may rank applications based on their perceived merit and only those near the top of the ranking.

Conditional Grant Award

As mentioned above, the Board may make a grant conditional upon you agreeing to perform some service to the Club that would make use of your newly acquired skills. Any condition applied is not meant to "get back" an amount of work equal to the value of the grant but rather to make use of the new skills so that others may learn from your experience. An example of a condition would be to participate in a lecture or outing of a course the WAC offers that could benefit from your knowledge.
